Sir,

The Director of State Lotteries, West Bengal has received a complaint from the West Bengal Lottery Stockists Syndicate Private Limited regarding running of unauthorised and paper lotteries and Satta in many parts of West Bengal. They have also submitted some lottery tickets circulated illegally in the name of Government of Bhutan.

The Directorate of State Lotteries, West Bengal has no information regarding selling of paper lottery tickets by Government of Bhutan in West Bengal. This type of activities may cause huge loss of revenue of the Government. So it is necessary to immediately stop the illegal paper lotteries and Satta to protect the interest of the State and also that of the common people who are buying such tickets.

You may kindly give necessary instruction for taking action to stop the illegal lotteries and Satta.
